# **Rising Waters Group Meeting**

Minutes of Sunday, March 26<sup>th</sup> 2019

#### Meeting opened at 2:10 – Trudi/Sciath chairing meeting as deputy seneschal

## **Officers Reports**

Barony & Baroness (Sam/Dmitri and Jennifer/Gema)

- Comic-con was a success, although it was a financial and staffing challenge.
- Discussion with nearby vendors/attractions suggest that we were charged more than we should have. We will need to confirm this with Niagara Comic-con, if we decide to do this again.
- Next Niagara Comic-Con is scheduled for June 5-7, 2020.
- Propose that we share costs for the booth with SCA neighbours (Rhydderch Hael and Ben Dunfirth), since they benefit from the involvement at the Con.

Action Item: We must locate the baronial parade banner.

- We will be attending Trillium War for Friday and Saturday.
- We attended the Deed of Arms event. We were impressed with the event itself, and hope to see it again.

#### Exchequer (Joey/Jowan)

- We have money in the bank.
- Please ensure that you include your name on the receipts, when submitting them to the Exchequer.
- Richard provided Joey with the returns and some receipts from Deed of Arms. There are a few receipts outstanding.

#### Thrown Weapons (David/Gunther)

- There have been regular practices at the Crumhold, with 4+ attending regularly

#### Archery (David/Gunther)

- Angie and Gillian have approached New Hope Church (NHC) to coordinate access to outdoor area for a regular practice site.
  - Storage was not part of the discussion at this time.
  - NHC is willing to discuss use of the facilities/groups for 2 nights/month
    - Cost is \$110/night
    - Suggestion of a mega-practice with Trinovantia Nova, Ben Dunfirth, and other groups interested.
    - Best night suggestion is for Friday (so long as it is not on an event weekend)

- Mistress Marioun is now the Education Officer for the Kingdom College of Scribes, and will be coordinating scriptoriums at events. She has made a request of baronies, which the seneschal's report will discuss further.

#### Chronicler (Jennifer/Gema)

- Technical challenges have made it difficult to publish them next issue of the Cataract. Jennifer is working on resolving the issue.

#### Seneschal (Trudi/Sciath, standing in for Sabrina/Annabelle)

 There has been a request for Baronies to sponsor items for beginning illumination gifts for people just starting out. Perhaps we can donate \$75.00 for pigments for the kits to the Signet office. Ben Dunfirth donated \$100.00 for paper for the kits. Skraeling Althing and Ramshaven have donations on the board. My vote is to approve the donation if it becomes a question.

#### Vote to approve donation of \$75 for purchase of pigments. Vote was unanimous.

- Until the Candidate is announced in Court at War of the Trillium, we cannot schedule candidate meetings or polling dates. At this point, we need to be flexible with scheduling the gathering and make sure it is after the announcement.

### Old Business

## Spring Coronation (Angie/Bera)

- Alternative approach group with a Fall 2020 event to negotiate switching responsibility for kingdom events.
