Fencing Marshal's Report (Sciath/Trudi)

- April 13 Sockburner: A nautical-themed fencing tournament.
 - Two ships have come along side each other, and fighting changes from ranged cannons to hand-to-hand as boarding planks are hooked from ship to ship.

- Your job is to defend your ship. The danger? There are no railings and if you step off the edge you fall into the sea and drown, or are eaten by the Kraken.
- Victory conditions:
 - 1) Defeat your opponent in combat,
 - 2) Force your opponent past the beginning of the ropes on their starting side,Or
 - 3) Cause your opponent to step off the boarding plank.
- Any amount of foot or body that touches the ground past the edge of the rope will be considered a fall-off. The marshal will call hold and indicate who 'fell off.' A 'fall off' is a loss.
- Fighters must start between the ropes and remain completely between the ropes for the duration of the fight. The last person standing is the winner.
- April 27 Coronation: TRH have asked for a fencing tournament to take place, but there are no details at this time.
- May 11 Lady Mary Memorial Tournament: There will be a fencing tournament to determine a winner of the Lady Mary Fencing Tournament, and to find a champion to succeed Sir Richard as Baronial Fencing Champion.
